Please be advised that any falsification of information given in the application will result in denial of tenancy. All persons age 18 years and older must submit an application.

AGENCY DISCLOSURE: Spalding Brokers, LLC represents the owner and is paid a fee by the owner to lease and manage said Property.

IDENTIFICATION: All applicants age 18 years and older must provide a copy of a current driver's license or current government issued photo id.

CONSIGNER: We do not work with Co-Signers. Each Applicant must live in the Property and be fully qualified.

INCOME/EMPLOYMENT:

- Each applicant must provide proof of at least one year of stable employment.
- Each applicant must provide the last 3 month's paycheck stubs with year to date earnings.
- Net Income must be equal to or greater than 3 times the monthly rent.
- Unrelated Roommates must each provide proof of income at least 2 times the monthly rent.
- Those who are self-employed must provide the last two years tax statements.

RENTAL HISTORY:

- Each applicant must provide rental history for the last two years showing proper notice was given, payments made on time, and no damages.
- If applicant has less than two years of rental history, a second deposit equal to one month rent will be required.
- If applicant has not rented and has mortgage history, then applicant agrees to allow Spalding Brokers, LLC to verify payment history with the lender.
